Key Course Components.

Foundations of Directorship[™] (Health) is designed for new or aspiring board members. The course provides a comprehensive Introduction to the three key components of directorship: governance, strategy and risk, and finance.

- Introduction to the strategic role of the director.
- Risk: Issues for directors.
